New IRA Tax Laws for the future and the past...

We have two new tax laws that have IRA provisions. One law contains IRA provisions that take effect years from now and the other law has provisions that can be used for prior years.

This month's feature article, "New Tax Law

Eliminates Eligibility Rules for Roth IRA Conversions" highlights the first of the two laws, The Tax Increase Prevention and Reconciliation Act (TIPRA) signed into law on May 17, 2006. TIPRA allows everyone to convert their traditional IRA balances to Roth IRAs beginning in 2010 by removing income and filing status restrictions. In addition, Congress has included an attractive payment plan to encourage IRA owners to convert. Even though these provisions do not take effect for a few years, there are planning moves that can be made now.

The other law which we cover on page 4, "The HERO Act," applies to

servicemen and women who receive combat pay. Even though combat pay is tax free, the new law allows them to treat that pay as compensation for IRA eligibility purposes and applies retroactively for 2004 and 2005. This will allow these men and women to make IRA contributions for back years.
